

## Solicitor's Permit Application & Ordinance

City Code of Ordinances, Chapter 111, Sections 111.01-111.13 Solicitors, Transient Vendors and

### **Sec. 111.01 Defined**

For the purposes of this division, the term "Solicitor" shall mean any person who requests donations or who attempts to sell or sells tangible property, including subscriptions to any paper, book, magazine, periodical or pamphlet, or who takes orders for magazines to be delivered by mail, freight or rail on the same day or in the future, or who attempts to sell or sells investment contracts or any type of contract and delivery is made on the same day or in the future, or who sells or attempts to sell personal service or services within the City of Troy.

### **Sec. 111.02, 111.05, 111.06, 111.07 Permit Required**

It shall be unlawful for any person to be a solicitor within the City without first obtaining a permit therefore, within ninety-six (96) hours after receiving an application for a permit required by this division. The police department shall investigate the application and notify the applicant and the Mayor if applicant's public record suggests that the best interests of the city would or would not be served by the issuance of a permit to the applicant.

### **Sec. 111.03 Application for Permit**

1. Application for a permit required by this division shall be made to the City Clerk.
2. The applicant shall sign the application stating his legal name, address, age, employer, local address and length of time in the City.

### **Sec. 111.04 Documents accompanying application for permit**

Each applicant for a permit required by this division shall furnish  
Evidence of his employment or that he is self-employed.  
Evidence that he is of legal age.  
A statement that he will notify the City when solicitations have been completed.

### **Sec. 111.08 Limitation on number of permits**

Not more than five (5) solicitor's permits shall be issued by the City at one (1) time.  
The limitation established by this section shall not include newspaper solicitors.

### **Sec. 111.10 Permit fee**

The fee for a permit required by this division shall be established by the City Council and shall be paid in the form of cash, bank draft or money order. The fee established by the Council is **\$20.00 per three days per person soliciting**. The permit shall be evidence of payment of the fee. Separate permit fees shall be paid by each solicitor.

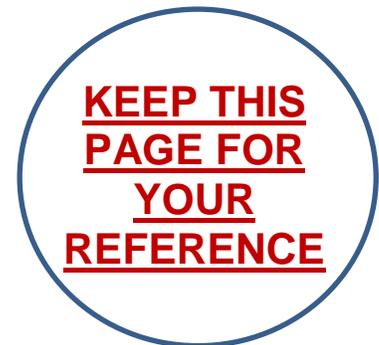
### **Sec. 111.11, 111.13 Revocation of permits**

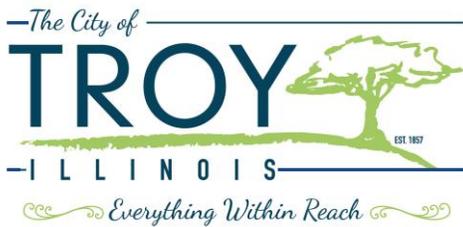
A permit issued pursuant to this division shall be revoked without a hearing if the solicitors violate any provision of this code, other ordinance of the City or State law or if any statement made in application for the permit is found to be false.

**Soliciting hours are between 9:00 a.m. and 5:00 p.m. Monday through Friday and 9:00 a.m. to 12:00 noon on Saturdays.**

### **Sec. 1211.12 Soliciting on uninvited premises**

It shall be unlawful for any person to go upon the premises of another for the purpose of soliciting without the consent or invitation of the owner or occupant of the premises.
